

# JEWISH PROFESSIONAL TUITION INCENTIVE FAQS

## What is the Jewish Professional Tuition Incentive?

HBHA is proud to pilot this incentive, which provides substantial tuition support for families of Jewish professionals (activity fees still apply).

- **First two years: 100% tuition incentive**
- Third year and beyond: 25% ongoing tuition incentive for as long as the family remains at HBHA and at least one parent or legal guardian qualifies as a “Jewish Professional” as defined herein.

## Why does HBHA offer a Jewish Professional Tuition Incentive?

The Jewish Professional Tuition Incentive honors and supports the meaningful contributions Jewish professionals make to our community. This incentive reflects HBHA’s **commitment to partnership and connection**, ensuring that the children of these professionals have access to an exceptional Jewish education while celebrating the positive impact their families have on our school and the broader Jewish community.

## Who is eligible for this tuition incentive?

The program is open to **new-to-HBHA families\***, with at least one parent or legal guardian who is a Jewish Professional, and children entering Kindergarten through 11th grade.

*\*Employees not eligible*

## What qualifies someone as a Jewish Professional?

Families qualify if at least one parent works **35 hours or more per week\*** for a **federated Jewish organization**—for example, a synagogue, JCC, Federation, or Federation-supported agency. Employment at **local, national, or global** Jewish organizations qualifies.

*\*Part-time employees at such organizations are encouraged to inquire; eligibility will be reviewed on a case-by-case basis.*

### **If I qualify, can I still apply for financial assistance?**

Yes. Families may **apply for financial assistance at any time**, regardless of their participation in the Jewish Professional Tuition Incentive.

### **If I have more than one child starting concurrently, does the incentive apply to all of them?**

Yes. **Every new student in your family**—regardless of grade level—will receive the tuition incentive. Families who continue into a second year will automatically receive the 100% incentive for each child for that year as well.

### **If we've attended HBHA before, can we qualify for this tuition incentive?**

No. This program is for families who have **never had a child attend HBHA**.

### **If I qualify and another child joins later, what tuition incentive will apply?**

The incentive is **based on how many years your family has been at HBHA**:

- In your family's first year at HBHA, all school-aged children (K–11) receive 100% tuition coverage.
- Any children entering the following year will receive 100% tuition coverage for that year only, as well as siblings who remain at HBHA.
- Beginning your family's third year and beyond, qualifying families receive 25% off tuition for all children annually.

### **If both parents are Jewish Professionals, does the incentive increase?**

No. The incentive **applies per family**, regardless of how many parents qualify.

### **Do I still need to apply to HBHA if I qualify for this incentive?**

Yes. All students must complete the HBHA admissions process. Receiving the tuition incentive is **contingent upon acceptance to the school**.

### **When and how do I apply for the Jewish Professional Tuition Incentive?**
